The Ottoman Empire, historically referred to as Turkey or the Turkish Empire, was a contiguous transcontinental empire founded by Turkish tribes under Osman Bey in north-western Anatolia in 1299. With the conquest of Constantinople by Mehmet II in 1453, the Ottoman state was transformed into an empire.

During the 16th and 17th centuries, in particular at the height of its power under the reign of Suleiman the Magnificent, the Ottoman Empire was one of the most powerful states in the world – a multinational, multilingual empire, controlling much of Southeast Europe, Western Asia and North Africa.

At the beginning of the 17th century the empire contained 32 provinces and numerous vassal states, some of which were later absorbed into the empire, while others were granted various types of autonomy during the course of centuries.

With Constantinople as its capital and control of vast lands around the Mediterranean basin, the Ottoman Empire was at the centre of interactions between the Eastern and Western worlds for over six centuries. It was dissolved in the aftermath of World War I; the collapse of the empire led to the emergence of the new political regime in Turkey itself, as well as the creation of the new Balkan and Middle East.

Education is compulsory and free for every child in The United States. Most children start school by the age of six. They attend eight years of elementary school and four years of high school (or secondary school). The money for free public schools comes from taxes, and each state is responsible for its own educational system. State legislatures set the educational requirements but leave the management of the schools in the hands of the local communities. Most states require their children to go to school until a certain age. This age varies from 16 to 18 years according to the laws of the individual states. The Federal government contributes funds to the states for additional schools and school services.

After graduation from high school, a student can start his higher education in a two-year college, a four-year college, a university, or a specialized professional school-either public or private. Most colleges admit students on the basis of their high-school records. The cost of a college education is expensive in private universities, but it is much less in those supported by states and cities. Many students receive scholarships from the schools, the government, or private foundations and organizations. More than 50 % of the college students work to help pay their college expenses. Only 2 % of the population of the country cannot read and write.
